# Setting up a Rental Company Fact Sheet – October 2018

# Legal implications

There are no special legal requirements for setting up a rental company beyond the normal legal requirements when starting up any other type of business. ## **Statutory requirements**

There is no statutory regulation or licensing scheme for the rental industry other than that the nature of a hire agreement may require your company to hold a consumer credit licence.

#### Consumer credit licence

You may need a consumer credit licence if the hiring agreement is capable of lasting more than 90 days or other aspects of the Consumer Credit Act such as a deferment of payment mean that the nature of the agreement is regulated by the Act.

## Buying a franchise/licensee

You may decide that the best way of entering into the rental industry is by way of a franchise agreement where vehicles systems and financing support are available. Companies who offer franchising arrangements in the rental industry are set out below.
